Prospective bidders should submit a formal intent and business proposal to this office following the below-listed format on or before with the following requirements:

> ✓ Business Profile (nature of business [single proprietorship, corporation or partnership, cooperative, etc.], registered name and name of owner/manager, location/address/phone number

- of the office, particular services offered, number of year/s months in food/catering business, and other pertinent information);
- ✓ Service Record (Record or Listing of institutions that have been served or being catered to or clients in Mountain Province – for reference purposes only, if any);
- ✓ Proposed/Offered Daily Menu (for meals and snacks items) with prices for each food viand/items;
- ✓ Legal requirements (photocopies of Business Permit, Mayor's Permit, DTI Registration, BIR Registration, Fire Safety Clearance/Certificate, Sanitation and Health Certification including those of the canteen staff, crew, and handlers)
- ✓ Other clearances (Police, Court, NBI, etc.)

Absence of any of these requirements, the application/proposal shall not be considered. These same requirements are to be used as criteria for preselecting the most suitable business proposals for our consideration.

The following information, terms and conditions would help all interested parties come up with a good business proposal:

- a. The above mentioned College property is available for rent with an initial contract for three years subject to renewal upon establishment of the lessee's track record of very satisfactory performance or above.
- b. The projected population that will need the services of the canteen is about 2,500 students and about 100 employees.
- c. The target is to have a canteen concessionaire that will operate from 6:30 AM until around 8:00PM, daily, from Monday to Friday of the week, and half-day of Saturday morning.
- d. The College shall provide tables and chairs and other furniture that are already present in the canteen premises.
- e. The monthly fee for the concessionaire is exclusive of water, electricity and housekeeping services for the common areas.
- f. The concessionaire is expected to provide regular food and beverage services for the community which shall consist of quality and hygienically-prepared meals (breakfast, lunch and dinner) and snacks items for students and clients. Beverage service shall consist of all forms on non-alcoholic and non-carbonated drinks.
- g. The concessionaire shall determine the prices of its products being sold, but at affordable prices particularly for the students/consumers.
- h. The Campus is an environment-friendly campus, as such, Styrofoam and single-use disposable products are not allowed. Re-usable dishware (plates, glasses, utensils, etc.) is a must for all concessionaires.
