Bid proposals/offers received in excess of the ABC shall be automatically rejected at bid opening.

Prospective bidders should possess a valid Business Permit/License applicable to the contract and have completed a similar contract with a value of atleast 50% of the ABC, and have key personnel and equipment(listed in Eligibility forms) available for the delivery of the services. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as the Preliminary Examination of Bids. The BAC will conduct post qualification of the lowest calculated bid.

The conduct of the Negotiated Procurement shall be governed by provisions of the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".
