The Mountain Province State Polytechnic College invites interested contractors to submit bid proposals/offer for the following projects subject for Negotiated Procurement:

Bid proposals/offers received in excess of the ABC shall be automatically rejected at bid opening.

Prospective bidders should possess a valid PCAB License applicable to the contract. Bidders must have completed a similar contract with value of at least 50% of the ABC and, have key personnel and equipment available for the implementation of the project.

The conduct of the Negotiated Procurement shall be governed by provisions of the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from the office of the BAC Secretariat at the 5th flr. beside the College Auditorium, Bontoc Campus.
